Vidhyut Utpadan Company Limited (VUCL) has allocated fund *toward the cost of Phukot Karnali PProR Hydro Electric Project (PKHEP) (480MW)* and intends to apply a portion of this *fund* to eligible payments under the Contract for which this Expression of Interest (EOI) is invited for **international consulting service**.
2. Vidhyut Utpadan Company Limited invites Expression of Interest (EOI) from eligible consulting firms ("consultant") to provide the Consulting Services for the ***In-Situ Rock Mechanical Test of Phukot Karnali PProR Hydro Electric Project (PKHEP) at Kalikot District*** (Contract No.: VUCL/PKHEP-RMT/S/QCBS/01/2079-80).

4. Consultants may associate with other consultants to enhance their qualifications.
5. Experienced, eligible and willing consulting Firms are invited to submit their EOI, either single or joint venture with other firms. The firm /JV shall submit EOI through PPMO's EGP system, **www.bolpatra.gov.np** on or before **12:00 Hrs; December 21, 2022** (2079/09/06). Hard copy shall not be entertained during submission of EOI.
6. The EOI shall be opened on **13:00 Hrs; December 21, 2022** (2079/09/06) at VUCL office.
7. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
8. EOI will be assessed based on the ***Qualification & Experience of Key Experts [30%], the Experience of Consulting Firms [55%], and the Capacity of the consulting firm [15%]***. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
9. Minimum score to pass the EOI is 70 out of 100 Marks.
