The Vidhyut Utpadan Company Limited has allocated funds towards the cost of Study of **Mugu Karnali Storage Hydro Electric Project (MKHEP, 1902MW)** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Test Adit Tunnels of MKHEP**. The project is located in Swamikartik Rural Municipality - 4 & Jagannath Rural Municipality-1, Piluchaur of Bajura district in Sudurpaschim Province, Nepal. Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Vidhyut Utpadan Company Limited invites Electronic Bids from eligible bidders for the **Construction of Test Adit Tunnels (Test Tunnels of 1348m length D Shaped of Size:2.2m X 2.5m and Test Chamber 60m of Size:6m X 6m at Dam Site area)** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Intended Completion Date for the whole of the Works shall be **within 24 (Twenty-Four) Months from the date of Contract Agreement**.





7. *Bidders shall visit Project Site with their technical manpower on their own cost to get the information regarding project location, accessibility to the site and weather condition of the project site before submission of their bids and shall submit SITE VISIT COMPLIANCE LETTER as an Additional Document of Technical Bid in accordance to ITB11.2h & Rule No. 62 of VUCL's Procurement Bylaw, 2077. However, a site visit shall not be organized by the Employer.*
8. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np](http://www.bolpatra.gov.np) under the name of public entity: **Vidhyut Utpadan Company Limited** on or before **12.00 hours on November 22, 2023**. Bids received after this deadline will be rejected.
